Shaman Foradi, Applicant, on behalf of Jain Family Holdings, LTD of has submitted a request for PUD rezoning and a large-scale Future Land Use (FLU) map amendment on thirty-six (36) acres located at 1800 & 2402 Maguire Rd., pursuant to the requirements of the Town of Windermere Land Development Code (LDC).
