# Town of Windermere Parks and Recreation Committee Proposed Meeting Minutes November 16, 2020

Call to Order: The meeting was called to order by Nora Brophy. She noted that a

quorum was present to approve official business.

# **Business Agenda**

### **Old Business/Events**

- A. Park Statue Donation Mr. John Nabors attended the PR meeting to announce a potential bronze statue donation for Windermere Parks. This is a Stanley Proctor artist bronze statue about 4 ½ feet tall. The members asked Mr. Nabors a few questions about the care and maintenance of the statue. It was also determined that the statue will ideally need a small concrete slab underneath which he will not be providing. The committee discussed several potential locations including 4<sup>th</sup> Street and Fernwood Park. Lesha Miller made a motion that was seconded and unanimously approved to accept the bronze statue donation.
- **B.** Windermere Pet Fest Nora announced that the event is on hold pending more COVID discussion and updates.
- C. 18<sup>th</sup> & 19<sup>th</sup> Annual Run Among the Lakes Nora indicated that 2020 event ended up with 655 participant runners. Talks are underway for 2021 including a new title sponsor. This prospective sponsor has requested a COVID refund clause which is being reviewed.
- **D.** Halloween Costume Parade Doug thanked the Mayor, Town Staff and Police Chief Ogden for being the core of this event. More candy had to be purchased for the kids because there were so many along the day of caravan route. Doug also thanked Town Manager Smith for suggesting this event idea during a past 2020 PR meeting.
- E. CIP Plans (Central) Nora mentioned that Schwartz & Associates has developed a proposal under \$10k to improved handicap access in the park including additional mulching. A motion was made and seconded to approve new swings and design/equipment to make the park more accessible for Central park guests. Susan Carter on behalf of the Tree Board will also be submitting a plan in the near future to upgrade the landscaping in the Park.
- **F.** Kayak Storage The general idea of kayak storage was discussed again and picking up from a prior meeting. Brief discussion ensued and some consensus that Windermere Rec Center might be the best initial location. Frank Krens

- indicated he needed more time to research, and this topic will be put on the agenda for an upcoming meeting.
- **G.** Fernwood Park Forum The proposed Boardwalk was discussed with an open forum for residents to comment during the meeting. Comments from participant residents included:
  - a. Mr. Gurnig He is concerned about the Boardwalk attracting rowdy beer drinkers
  - b. Angela Withers She focused on impacts to wetlands and budget for planting landscaping in any affected area including having Landscape Architects make these decisions
  - c. Jim Willard He indicated that his personal feeling about a cost/benefit analysis was not positive. He also voiced concern about pedestrian access and safety.
  - d. Bill Osborne He expressed concern about in house planning of this amenity
  - e. Tom Stroup He reiterated that attractive more people to the park is negative
  - f. Jessica Lee She indicated her opposition due to mixing the amenity with boat ramp access
  - g. Anna Clonts Her expressed feelings are about a loss of quality of life for those near the park
  - h. Ron Tegler He is concerned about the pedestrian safety issue and the size of the Boardwalk
- H. Fernwood Park Action The committee turned their focus on the larger issue of the stormwater plan and how this effects Fernwood park planning including the Boardwalk. The Kimly Horn firm to design impact plans which may take up to 6 months. The desire of the committee is to meet with Kimly Horn to understand park impact and then to work with IDG to design park elements around these plans. Discussion ensued around separating approval of the Boardwalk from general clean-up and landscaping improvements for the park. Lesha made a motion that was seconded and unanimously approved to move forward in this regard on the clean-up and landscaping improvements.

A resident asked the Committee to articulate their larger plan to move forward on the Fernwood Park Boardwalk issue. After some discussion, Doug Bowman made a motion to table the existing Boardwalk plan, and move forward with more discussion and input after the Kimly Horn stormwater plan has been formulated. A motion was made and seconded to reconsider the Boardwalk again if/when Kimly Horn has developed their recommendations in the near future. This motion was approved unanimously.

#### **New Business**

- **A.** Minutes Approval Meeting minutes from October, 2020 were unanimously approved as submitted based on motion approvals.
- **B.** Adjournment The meeting was adjourned at approximately 6:00 p.m.
