### OLD BUSINESS

- 1887 Schoolhouse RFP status. Theresa says the 1916 school has a master site file, it is part of our historic district and it is recognized as an historic building. It is on the local historic registry. Carl Patterson has a record.

Andy said Scott and he reached out to the two names - didn't pan out. Amanda has an engineering report from HB Associates. They are an engineering and building company, so they can do it all for \$6500. We will use their report as a basis for the other bids. Theresa will text a few more names to Andy. Horizontal wood slatting for the schoolhouse exterior is most original, so we agree to keep it that way with restoration. Heart pine or cypress would be most logical and affordable material. We will later decide if painted or stained wood would be most appropriate.

### - ORAL HISTORY PROJECT

Andrew McGhee says Michigan State and UPenn have the best oral history projects. He is modeling his project off them. List of participants we want to interview. We need to identify interviewers. Volunteers get trained. So there is consistency. They use a list of questions. Not a rigid structure. Pick a training date for the volunteers, perhaps a 4 hour workshop. Getting the list of volunteers comes first - use Town Website, FB page, asking for volunteers (maybe Gazette too). Audio/video is what we want. Andrew will volunteer his time for camera work, not much editing involved. Location - usually it is done in their homes (where they are comfortable). Interview release forms - permission to use the data (will be in the packet Andrew will send us). Archival structure - how will preserve it and present it.
