Town Council Meeting Minutes

June 8, 2021

CALL TO ORDER:

Present were Mayor Jim O'Brien, Council Members Andy Williams, Chris Sapp, Bill Martini, Mandy David and Tony Davit. Town Manager Robert Smith, Attorney Heather Ramos, Deputy Police Chief Jennifer Treadwell, and Public Works Director Tonya Elliott-Moore were also present.

Mayor O'Brien called the meeting to order at 6:03pm and stated quorum was present. He then led everyone in the Pledge of Allegiance and gave the invocation.

Mayor O'Brien stated that Ms. Susan Carter deferred until the Public Hearing item.

3. TIMED ITEMS AND PUBLIC HEARING:

ORDINANCE 2021-01

AN ORDINANCE OF THE TOWN OF WINDERMERE, FLORIDA, PERTAINING TO REZONING; AMENDING THE TOWN OF WINDERMERE'S ZONING MAP FOR 2.17 ACRES MORE OR LESS OF REAL PROPERTY LOCATED WITHIN THE TOWN CENTER DISTRICT OVERLAY AT THE NORTHEAST CORNER OF MAIN STREET AND EAST 6TH AVENUE, AS MORE SPECIFICALLY DESCRIBED HEREIN, FROM COMMERCIAL AND RESIDENTIAL ZONING TO PLANNED UNIT DEVELOPMENT; PROVIDING FOR APPLICABILITY; SEVERABILITY; CONFLICTS; CODIFICATION; AND AN EFFECTIVE DATE.

Mayor O'Brien turned the floor over to Attorney Ramos. Attorney Ramos explained the Quasi-Judicial process that will need to take place. Mayor O'Brien questioned if there were anyone who is and affected party and would like to make comments. Mr. Daniel Floyd of 515 Oakdale Street introduced himself as an immediate neighbor. Clerk Burkhalter then swore in Town Planner Brad Cornelius. Mayor O'Brien then requested that the Town Council disclose and contacts, discussions, etc. that they have had. Council member Martini disclosed that on May 12th he met with Jim Karr and Susan Carter regarding trees. Council member Sapp disclosed that he did a walk through with the applicant. She then stated that he is a tenant with no financial benefit. Council member Davit stated he had conversation with Mr. Cornelius regarding the traffic study. Council member David disclosed that she has spoken with Mr. Cornelius regarding rezoning. Mayor O'Brien disclosed that he has spoken with Mr. Cornelius, Mr. Karr and Ms. Susan Carter. Council member Williams stated he will be abstaining. Mayor O'Brien turned the floor over to Mr. Brad Cornelius. Mr. Cornelius stated that this is the second and final public hearing. He then gave an overview of the proposed project. After the brief presentation, Mr. Cornelius explained that that this will take a 70% vote approval by the Town Council. Discussion was made regarding septic/packaging plant. Mayor O'Brien opened the floor to Ms. Susan Carter of 106 Palm Street. Ms. Carter commented on that the arborist needed to be an ISA Certified Arborist. She also commented on the tree survey and that the yellow house doesn't seem to be included. Mayor O'Brien turned the floor over to the applicant. Clerk Burkhalter Swore in Mr. Jim Hall. Mr. Hall stated he was present to answer any questions anyone might have. Manager Smith commented that Mr. Karr would like the Arborist capped at \$5,000.00 which the Town Council would need to agree to. He also commented that the Town Council would need to accept a packaging plant system or a septic system. Mayor O'Brien stated that additional information is needed for the packaging plant system prior to an approval. Mr. Hall commented on new updated systems that are now being utilized in other projects. Mr. Cornelius stated that options can be discussed at a later date. Council consensus is to not allow a cap for the Arborist. Mayor O'Brien opened the floor to the public. First to speak was Mr. Daniel Floyd resident of 515 Oakdale Street. Mr. Floyd questioned the retention pond. He questioned if it would be dry or a pond. Mr. Cornelius stated that it had not been determined. Mr. Floyd then questioned if the parking would be for tenants or clients. Mr. Cornelius stated that the plans do not dictate the parking. Discussion followed regarding parking. Mr. Karr commented that the retention is not intended to be a wet pond. Ms. Susan Carter commented that more trees need to be saved, additional root protection, and the tree board be involved with landscape plan and fencing. There being no further public comments, Mayor O'Brien closed the Town Council

WHO MUST FILE FORM 8B

This form is for use by any person serving at the county, city, or other local level of government on an appointed or elected board, council, commission, authority, or committee. It applies to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

Your responsibilities under the law when faced with voting on a measure in which you have a conflict of interest will vary greatly depending on whether you hold an elective or appointive position. For this reason, please pay close attention to the instructions on this form before completing and filling the form.

INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office MUST ABSTAIN from voting on a measure which would inure to his or her special private gain or loss. Each elected or appointed local officer also MUST ABSTAIN from knowingly voting on a measure which would inure to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent, subsidiary, or sibling organization of a principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies (CRAs) under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

ELECTED OFFICERS:

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your Interest In the measure on which you are abstaining from voting; and

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the
minutes of the meeting, who will incorporate the form in the minutes. (Continued on page 2)

- · A copy of the form must be provided immediately to the other members of the agency.
- · The form must be read publicly at the next meeting after the form is filed.

IF YOU MAKE NO ATTEMPT TO INFLUENCE THE DECISION EXCEPT BY DISCUSSION AT THE MEETING:

- You must disclose orally the nature of your conflict in the measure before participating.
- You must complete the form and file it within 15 days after the vote occurs with the person responsible for recording the minutes of the
 meeting, who must incorporate the form in the minutes. A copy of the form must be provided immediately to the other members of the
 agency, and the form must be read publicly at the next meeting after the form is filed.
