

## PARK PASS FOR BOAT RAMPS

- 1) Property owners and residents of the Town of Windermere may launch and recover boats within the Town from Town property providing they have obtained a Park Pass, which must be renewed annually. The pass must be displayed on the dashboard of a vehicle.
- 2) The annual Park Pass may be obtained upon payment of a fee to the Town in an amount to be established by resolution of the Town Council. Unless and until the Town Council adopts a resolution establishing new fees, the Park Pass fee amount shall be **\$35.00**, which includes a key to the Lake Bessie Boat Ramp, and codes to both the Fernwood Park Pedestrian Gate and the Fernwood Park Boat Ramp. **There is no discounted rate for residents wishing for access to only one ramp or for residents renewing late in the year.** The passes shall be renewable each year by a date set by resolution of the Town Council. Unless and until the Town Council adopts a resolution changing the renewal date, Park Passes shall be renewable each year by **October 1**.
- 3) Boat launching and recovery locations are: (i) Seventh Avenue at Butler Street at Fernwood Park, and (ii) Ninth Avenue at Lake Bessie. It is unlawful for a boat to be launched or recovered from any Town property by any resident or property owner of the Town, except at these two places or the public Orange County ramp located on E 6<sup>th</sup> Avenue on Lake Down. Nonresidents or nonowners of property in the Town shall not launch or recover a boat from Town property except from the public Orange County ramp located on E 6<sup>th</sup> Avenue on Lake Down.
- 4) Residents who only wish for a pedestrian gate code at Fernwood will be provided one for no charge. The passes shall be renewable each year by a date set by resolution of the Town Council. Unless and until the Town Council adopts a resolution changing the renewal date, Park Passes shall be renewable each year by **October 1**.
- 5) The gates to the boat launching areas are kept locked and a key/code will be issued with each pass. Replacement keys/codes are available for \$5.00 each. **Property owners and residents are responsible for closing and locking the gates after use.**
- 6) It is unlawful for any boat trailer to be parked on any Town-owned property or road right-of-way within the Town limits, unless such parking is authorized in writing, by the Town Manager. Unauthorized boat-trailer parking shall be punished by a minimum fine of \$100.00 and a maximum fine not to exceed \$200.00.

**PARK PASSES & KEYS/CODES ARE FOR THE USE OF WINDERMERE RESIDENTS ONLY, AND MAY NOT BE COPIED OR LOANED TO ANY PERSON OTHER THAN A MEMBER OF THE APPLICANT'S HOUSEHOLD, EVEN IF HE OR SHE IS A TOWN RESIDENT. THE TOWN HAS ACCESS TO INFORMATION SHOWING THE FREQUENCY OF THE USE OF AN INDIVIDUAL ACCESS CODE.**

### **VIOLATION OF THE RULES WILL RESULT IN THE FOLLOWING: (PLEASE READ AND INITIAL EACH STATEMENT)**

\_\_\_\_\_ **VIOLATION 1:** Should a **non-member** of the applicant's household be in possession of **the applicant's** key, code, or pass without prior authorization of the Town, such key, code, and/or pass will be confiscated and the applicant's household will not be eligible for renewal for 1 year from date of the offense.

\_\_\_\_\_ **VIOLATION 2:** Should a **non-member** of the applicant's household be in possession of **the applicant's** key, code, or pass without prior authorization of the Town, such key, code, and/or pass will be confiscated and the applicant's household will not be eligible for renewal for 2 years from the date of the offense.

\_\_\_\_\_ **VIOLATION 3:** Should a **non-member** of the applicant's household be in possession of **the applicant's** key, code, or pass without prior authorization of the Town, such key, code, and/or pass will be confiscated. **Furthermore**, that applicant's household will be precluded from obtaining a pass for 2 years from the date of offense, **and the** non-resident will be trespassed from the town boat ramp areas for a period of 1 year.
