- 1. Call to Order: The meeting was called to order at 6:25pm by Dena O'Malley based on a quorum present to conduct business.
- 2. Open Forum/Public Comment (3 minute limit)
  Jill Ata at 5 Pine Street noticed landscaping issues: weeds and pests not maintained which impacts resident use as well as aesthetics.
