# a. Lake Street Parks Solutions Update

Mr. Walters commented on past concerns with parking. Ms. O'Malley questioned if the gate code would be similar to Fernwood. Manager Smith said yes. Mrs. Mitchell commented on the parking spots at 4th Avenue parking full access for residents. After some discussion was made Manager Smith thanked all for their input.
